TERMS AND CONDITIONS

Application and terms extended to the applicant by Kalan LP are governed by these terms and by any state and federal laws as applicable. By signing the application and agreement, the applicant or legal representative thereof agrees to be bound by these terms and conditions.

1. The applicant agrees to be bound by the terms and conditions of this credit agreement in whole as stated on all pages listed and agrees that an application submitted electronically will be deemed as original for the purposes of this agreement.
2. The applicant agrees to permit Kalan LP to check applicants' bank/financial institution and trade references not solely at the time of establishing their account but periodically at unspecified future dates to maintain assigned credit terms.
3. The applicant agrees that no oral agreements or modifications will be accepted or effective.
4. The applicant understands that any discounts applicable to their purchases will be listed on the order and invoice and are for that sale only and are separate and distinct from their obligations as stated in this agreement.
5. Kalan LP, located at 97 South Union Avenue, Lansdowne, Pennsylvania shall be considered the Point of Sale for all goods and services rendered by Kalan LP and said transaction shall be governed by the laws of the state of Pennsylvania. All laws governing the credit extended to applicant, payment of goods, and collection thereof, including any disputes arising from the transaction shall be governed by the laws of Pennsylvania.
6. All sales are final and no merchandise may be returned unless a Kalan LP employee furnishes a Return Authorization number. If the return is approved, applicant shall pay the cost of shipping the return and any restocking fee imposed unless a Kalan LP employee otherwise waives the charges. Any credits issued will be based on the count performed at Kalan LP when the product is received for credit.
7. The applicant agrees that when any goods are returned to Kalan, a credit for said goods will be issued that can be used for future purposes only and no cash refunds will be given. The applicant acknowledges and agrees that all credits must be used within one year of issue and that unused credits will expire.



8. The applicant agrees to pay all invoices within the due date as specified on each invoice. Invoices unpaid in excess of 10 days beyond the final due date of an invoice will be assessed a one-time late fee of \$15.00 per invoice.
9. The applicant acknowledges that Kalan will impose a 1.5% per month finance charge on past due invoices.
10. The applicant agrees that any disputes of charges on an invoice by the applicant will be initiated within thirty (30) days of the receipt of the invoice.
11. Checks received in payment of invoices may not be postdated and checks will not be held for deposit at a specified or unspecified future date.
12. Checks returned for non-sufficient funds shall incur a returned check fee of \$35.00 to be assessed against the applicant's account. The applicant agrees to pay this fee before any future orders are released.
13. Applicant attests to financial responsibility, ability and willingness to pay all invoices in accordance with the terms established.
